- I will assist in resolving behavioral issues involving my child and understand that the Connecticut Field Hockey Camp reserves the right to take disciplinary action, including dismissal from program <sup>[[1]]</sup><sub>SEP</sub> activities, without refund. <sup>[[1]]</sup><sub>SEP</sub> I understand the above referenced conduct expectations, I have explained such expectations to my child and believe that he/she understands them. I further acknowledge that any violation of such conduct expectations could lead to disciplinary action, including but not limited to, prompt dismissal from the Program, forfeiting camp fees, and denial from participation in future activities.
